DESCRIPTION: THE LODGE IS SITUATED ON NORTH RIDGE DRIVE, ADJACENT TO THE WATER TOWER, WITH A CAPACITY OF 500 FOR BOTH INDOOR AND OUTDOOR EVENTS. IT HAS TWO FLOORS AND TABLES & CHAIRS TO SEAT UP TO 135 PEOPLE. IT HOUSES AN OUTSIDE BANDSTAND AND PLAYGROUND. THIS BUILDING DOES NOT HAVE AIR CONDITIONING, BUT IT IS HEATED.

TEAMS NEEDING SPECIAL ACCOMMODATIONS ARE WELCOME AND ENCOURAGED TO PARTICIPATE. EACH ROUND IS LIMITED TO 10 TEAMS.

ALL TEAMS WILL WORK FROM THE PARKING LOT AND THEIR CARS. ONLY THE JUDGE AND TIMER WILL BE INSIDE THE BUILDING WHILE TEAMS ARE SEARCHING.

C-WAGS Notice to Exhibitors

C-WAGS NOTICE TO EXHIBITORS COMPETITORS, THROUGH SUBMISSION OF AN ENTRY, ACKNOWLEDGE THAT THEY ARE KNOWLEDGEABLE OF C-WAGS SCENT RULES AND REGULATIONS, INCLUDING BUT NOT LIMITED TO THE FOLLOWING RULES REGARDING ENTRY:

- ALL EXHIBITORS ARE EXPECTED TO TREAT THE JUDGES, TRIAL HOSTS, THEIR CANINE PARTNER, AND ALL OTHER EXHIBITORS WITH RESPECT.
- ALL JUDGES AND TRIAL HOSTS ARE EXPECTED TO SHOW RESPECT TO ALL EXHIBITORS.
- THIS TRIAL IS OPEN TO ALL DOGS REGISTERED WITH C-WAGS.
- TRIAL HOSTS MAY ELECT TO ACCEPT FOR EXHIBITION ONLY ENTRIES OF NON-REGISTERED DOGS.
- TEAMS MAY BE ENTERED IN MULTIPLE LEVELS/CLASSES AT THE SAME TRIAL.
- DOGS MUST BE SHOWN BY A MEMBER OF THE OWNER'S IMMEDIATE FAMILY.
- COLLARS: THE DOG MUST WEAR A FLAT-TYPE COLLAR (BUCKLE, SNAP, OR PROPER-FIT MARTINGALE) AND/OR BODY HARNESS. ELECTRONIC TRAINING, PRONG COLLARS, AND CHOKE CHAINS ARE NOT PERMITTED AT THE EVENTS.
- DOGS MUST BE ON A LEASH ON THE SHOW GROUNDS, UNLESS THEY ARE BEING SHOWN.
- OWNERS WITH DISABILITIES ARE ENCOURAGED TO PARTICIPATE IN COMPETITIONS. ANY NECESSARY MODIFICATIONS TO THE EXERCISES MUST BE PROVIDED BY THE HANDLER TO THE JUDGE AND APPROVED BY THE JUDGE.
- SAFETY SHALL ALWAYS BE THE FOREMOST CONSIDERATION IN THE ACTIONS AND CONDUCT OF HANDLERS AT ALL TIMES.

- BY ENTERING THIS EVENT, HANDLERS ACKNOWLEDGE FULL RESPONSIBILITY FOR THEIR OWN ACTIONS AND THOSE OF THEIR DOGS.
- THE ORGANIZING COMMITTEE RESERVES THE RIGHT TO REFUSE ENTRY TO ANY INDIVIDUAL FOR ANY REASON.
- THERE SHALL BE NO REFUND FOR ENTRIES IN THE EVENT A DOG AND/OR HANDLER IS DISMISSED FROM COMPETITION, REGARDLESS OF THE REASON FOR SUCH DISMISSAL. THERE WILL BE NO REFUNDS IF THE TRIAL IS CANCELED FOR ANY REASON.
- REFUNDS WILL BE MADE FOR FEMALES IN SEASON UPON WRITTEN REQUEST ACCOMPANIED BY A STATEMENT FROM THE EXHIBITOR'S VETERINARIAN.
- ALL COMPETITORS WHO ENTER THIS EVENT WAIVE ANY RIGHTS RELATIVE TO THE VIDEO BROADCAST OF THIS EVENT. COMPETITORS SHALL HAVE THE RIGHT TO VIDEOTAPE PORTIONS OF THIS EVENT FOR THEIR PERSONAL USE ONLY. NO PORTION OF THIS EVENT MAY BE VIDEOTAPED FOR COMMERCIAL OR OTHER PURPOSES.
